



GUIDELINES FOR PAPER SUBMISSIONS

All speakers are encouraged to submit a full length paper. However, paper submission is not mandatory. Papers can be submitted to respective session organizers through E-mail either before or after ICAS-VIII till December 15, 2019.

The session organizer(s) are requested to send the papers received from presenters to the Conference Secretariat.

The full papers received from the respective session organizers by the Secretariat till November 08, 2019 will be uploaded on website before the Conference. The full papers received by Secretariat after November 08, 2019, will be hosted after December 15, 2019.

1. The paper must be written and presented in English.
2. The paper must be submitted as PDF files to the Session Organizer with a copy to icas2019@icar.gov.in
3. The PDF file must have no security protection.
4. Template for preparing the paper is given below. Please use Font Type: Times New Roman.
5. Use single-spacing, font type 'Times New Roman' and font size 12. Paper Title may be given in font size 14.
6. The number of pages is 10-12 pages including title, author(s)' name (s) and affiliation(s), abstract, paper content, figures, tables and references.
7. Do not use page numbers.
8. In the file name, please do include the Abstract ID at the footnote.
9. The authors should mention explicitly in the E-mail sent to Session Organizer that they have no objection in uploading the full length papers in open access. The authors should specify at footnote on first page of the manuscript that the text/material is free from any Copyrights violations.

Please organize the paper as follows

- i) Title: Start with the title (as submitted along with abstract), which should be in bold letters and centred. It should be concise and clearly convey the subject of the paper.
- ii) Name(s) of Author(s): Continue with the list of authors. Please add an asterisk next to the name of the presenting author (speaker), who should also be the corresponding author. For each author, please provide organizational affiliation, name of city and country of residence, and e-mail address.
- iii) Abstract
- iv) Keywords: A list of keywords (maximum of five) must be included after the text of the abstract. Words from the title should not be repeated in the list of keywords.
- v) Body of paper: Organize the paper in sections:
 - Introduction
 - Methodology
 - Results

- Discussion and Conclusion
 - The text should be fully justified (left and right).
 - Figures and tables and corresponding titles should be centred. Please include table and figure numbers and captions, and use them to cite the tables and figures in the text
 - Colour graphics are acceptable.
 - Citations to references within the text should follow the style used in statistical journals such as the International Statistical Review: e.g. Fisher (1925); McCullagh, P., & Nelder, J. A. (1983); Box et al. (2013).
- vi) References: Follow formatting rules used in statistical journals, such as the International Statistical Review.
- Examples:**
 Fisher, R. A. (1925). Statistical methods for research workers. Genesis Publishing Pvt Ltd.
 Box, G. E.; Jenkins. G.M. & Reinsel G.C. (2013). Time series analysis: forecasting and control. John Wiley & Sons.
- vii) Abbreviations should be spelt out fully the first time they occur. (Example: The properties of maximum likelihood estimators (MLEs) are developed. The small-sample performance of the MLEs is studied through simulation.)
- viii) Double check for scientific accuracy as well as for clarity, proper grammar and punctuation before submitting the paper.
- ix) All queries should be sent to icas2019@icar.gov.in
